
Five characteristics of King Zollinger

Assessing Multilateral Effectiveness at Country Level

For the fourth time since 2004, King Zollinger supported the Annual MOPAN' Survey of partnership behaviour of multilateral organizations towards national stakeholders on the one hand and other international development organizations on the other. The focus of the

Survey on multilateral contributions to policy dialogue, advocacy, capacity development, alignment, information sharing, inter-agency coordination and harmonization at the country level reflects the emphasis of the international community on the quality and effectiveness of aid. The 2007 Annual MOPAN covered the United Development Programme (UNDP), the World Health Organization (WHO) and the African Development Bank (AfDB). As in earlier years, we managed the hotline for MOPAN country teams, wrote the Synthesis Report² and suggested improvements to the Survey methodology.

Monitoring Swiss Cooperation in Multilateral Development

The goals for Swiss multilateral development cooperation are defined in Switzerland's Multilateral Development Cooperation Strategy. In 2007, King Zollinger provided

methodological support for developing and piloting an instrument for monitoring Switzerland's interaction with its multilateral partners. This is intended to help improve the strategic management of Switzerland's multilateral cooperation as well as to enhance Switzerland's accountability for its multilateral financing.

Developing Strategic Recommendations for the UN Special Adviser on Sport for Development and Peace

In early 2007, the UN Special Adviser on Sport for Development and Peace, Under-Secretary-General Adolf Ogi, initiated a process to develop recommendations for the future strategic

focus of multilateral efforts for sport for development and peace. Urs Zollinger facilitated this process and - in close consultation with key actors and stakeholders in New York and Geneva - drafted recommendations for the attention of the new UN Secretary-General Ban Ki-moon. Based on these recommendations, he also provided advice on the future institutional set-up of the UN Special Adviser's office and support to the preparation of an annual Strategic Plan 2008.

Evaluating UN Reforms at Country Level

In November 2006, the UN Secretary-General's High-level Panel on UN System-wide Coherence in the Areas of Development, Humanitarian Assistance and the Environment published its report entitled "Delivering as One". In order for the UN system to become more coherent, effective and efficient, the report recommends that it introduce the concepts of one leader, one programme, one budgetary framework and one office at the country level. By February 2007, 8 countries were designated as pilot countries, i.e. Albania, Cape Verde, Mozambique, Pakistan, Rwanda, Tanzania, Uruguay and Viet Nam. Given the intention of the UN to evaluate the reform process in the pilots in 2009, Alison King contributed to a United Nations Evaluation Group mission to Viet Nam in October 2007, the scope of which was to assess the evaluability of the ongoing UN reform process in the country. Subsequently, Alison King was asked to contribute to further evaluability assessment missions to other pilot countries in early 2008.

Developing a Funding Proposal for the UN Global Compact Office

Established in 2000, the UN Global Compact has grown into an international network involving the UN and more than 4,500 business participants and stakeholders from approximately 120 countries, leading to increasing demands and expectations. The rising profile of the UNGC has also invited greater scrutiny and expectations with respect to improved accountability and transparency. In 2007, King Zollinger was asked to support the UN Global Compact Office to devise a funding proposal to donor governments for the next 3-year phase that responds to these challenges. In close collaboration with the team in New York, Urs Zollinger suggested an outline for a new funding proposal, provided methodological guidance with regard to the definition of objectives, success indicators,

activities and outputs. Particular attention was given to the setting of clear priorities, the allocation of financial resources and staff time to the achievement of the different objectives. So far, the initial donor reactions to the proposal are encouraging.

Establishing a Foundation to Support the Millennium Development Goals

With King Zollinger providing advisory support, the Centre for the Millennium Development Goals (CMDG) was established in Basle at the end of 2006.⁴ Its two overarching goals are to raise awareness of the MDGs and the United Nations work on the MDGs on the one hand and to provide a platform for engaging civil society in a constructive dialogue around the

MDGs and the UN on the other. In 2007, we continued to provide conceptual and strategic development policy advice to the start-up phase. The CMDG is supported by the former UN Secretary-General, Kofi Annan: "The work of the CMDG, I am confident, can have a significant multiplier effect and make a difference in reducing global poverty."

Formulating a Youth & Development Policy

Today's generation of youth is the largest in human history. Young men and women aged 15 to 24 account for more than one billion people, 85% of whom live in developing countries. Through stronger involvement of youth in policy dialogue and decision-making and by

investing more in the human capital of youth (e.g. health and education), developping countries now have the unique opportunity to massively reduce poverty. In 2007, Alison King helped to formulate a new SDC Youth Policy⁵ and drafted the manuscript. implementation of the Policy - one of the first of its kind - aims at achieving three main goals: supporting young people in developing their potential, improving their living conditions, and giving them a greater voice in political decisionmaking processes. It is being implemented through SDC programmes and projects in developing and transition countries.

Defining Future Arrangements for the Mountain Partnership Secretariat at FAO

Launched at the World Summit for Sustainable Development in 2002, the Mountain Partnership is a global alliance of governmental and non-governmental partners to support positive change in mountain areas. In March 2007, Urs Zollinger facilitated a two-day workshop in Rome, during which participants defined future arrangements for the

Mountain Partnership Secretariat, based in FAO. The workshop followed an external evaluation of the Secretariat and brought together a number of different stakeholders, i.e. representatives from the Governments of Italy and Switzerland, UN agencies, research institutions and NGOs. It concluded successfully with a key decision for a more decentralised Secretariat and a clear road map for the next phase. Moving towards implementation, Urs Zollinger subsequently facilitated a second workshop in July for operationalizing the road map.



Conducting Training on Sustainable Development and Globalization at the University of Berne

In June 2007, Urs Zollinger was co-responsible for the realization of a two-day seminar on sustainability and globalization as part of Certificate of Advanced Studies on Sustainable Development at the University of Berne. Urs Zollinger dedicated his main lecture to the topic "The Effects of Globalization on Sustainable Development and the Challenges to Global Governance". Moreover, working groups looked into different questions about globalization, among other things the question of global income distribution. Urs Zollinger was also responsible for evaluating the final papers submitted by the participants. The certificate course is being repeated in 2008/2009.

In October 2007, Urs Zollinger facilitated a high-level UNEP workshop in Geneva. The purpose of the workshop was to gather inputs on how to strengthen the involvement of major civil society actors in the United Nations Environment Programme (UNEP) at governance and implementation levels.

2008 Annual Programme Planning of the FAO Right to Food Unit

In December 2007, King Zollinger was asked to facilitate the annual planning process of the Right to Food Unit at FAO in Rome. FAO was looking for "a facilitator from outside the organization with extensive experience in planning processes, experience with strategy development, and well acquainted with the donor as well as the UN perspectives of

development work". Urs Zollinger prepared and managed a 2-day retreat, provided methodological support and prepared a retreat paper pulling together the elements developed during the retreat.

Urs Zollinger, a Swiss citizen, obtained his Master's degree in Economic Sciences from the University of St. Gallen, Switzerland, in 1992. He has an in-depth understanding of the international development cooperation system and of today's concepts of sustainable development and globalization. Before founding King Zollinger, Urs Zollinger worked with the UN Development Division of SDC where he represented Switzerland on the UNDP Executive Board

(1999-2003). Earlier, he gained operational work experience at the country-level with UNIDO

in India (1995-1997) and served in the UNDP Evaluation Office in New York (1997-1999) where he provided support to the conceptual development and worldwide introduction of UNDP's results-oriented management. Before joining the international development community, Urs Zollinger worked as brand manager for Unilever. He has a large amount of experience in monitoring and evaluation and is a skilful trainer, moderator and facilitator.
